#### **1.4) Guidelines for retaining of EMD**

The Earnest Money Deposit (EMD) of the top three bidders—H1, H2, and H3—will be retained for 15 working days. If H1 (the highest bidder) fails to deposit the full payment within the stipulated time, their EMD will be forfeited, and the salvage will be offered to H2 (the second-highest bidder) at their bid amount. H2 must honor the bid; failure to do so will result in forfeiture of H2's EMD. In such a case, H3 (the third-highest bidder) will be invited to purchase the salvage at their bid price and will similarly be required to proceed with the purchase, failing which their EMD will also be forfeited.

EMDs will not accrue any interest. If H1 completes the full payment within the specified time, the EMDs of H2 and H3 will be refunded within 5 working days. EMDs of all other bidders (excluding H1, H2, and H3) will be returned within 5 working days after the bidding process concludes, without any interest.

For the successful bidder, the EMD will be retained and directly transferred to the seller's account at the time of final lifting of the sold property.

#### **1.5) Commercial Terms**

### **2) Inspection of Salvage & related guidelines**

#### **2.1) Last date for inspection**

Inspection of salvage can be carried out after prior appointment till the day before commencement of bid.

#### **2.2) Basis of Sale / disposal**

The items offered for sale are strictly on “**As is where is basis with all faults**”, “**As is what is basis**”, “**Whatever there is**” & “**no complaint basis**”.

#### **2.3) Responsibility of Bidder**

It shall be the duty of the bidder to inspect the salvage properly & evaluate its properly with all terms & conditions. Participation in bidding shall be treated as conclusive evidence of the fact that the bidder has inspected the items put for disposal & satisfied himself in all respects.

### **3) Bidding procedure, Award of contract & Payment terms**

#### **3.1) Bidding Procedure : The bidding will be carried out in 2 phases.**

**1<sup>st</sup> tier bidding** will take place on 27.05.2025 & at the conclusion of this H1, H2 & H3 will be identified.

**2<sup>nd</sup> tier bidding** will be conducted on next day at the same time wherein H1, H2 & H3 only will complete against each other to give highest salvage value.

**Note : This 2-tier bidding system avoids manual negotiation & automates the entire salvage evaluation process including negotiation without human intervention.**

#### **3.2) The final acceptance of the highest offer received will be at the sole discretion of Insurance Surveyor / Seller / Insurers.**

- 3.3) Immediate payment covering shortfall in EMD :** The highest bidder will submit amount equivalent to 10% of the highest bid value (after taking consideration of EMD) with JSR Bids by the end of next working day from date of bidding to cover up difference in EMD deposited & revised EMD as per highest bid amount.
- 3.4)** Upon finalization of price & approval by Surveyor / Seller, M/s. JSR Bids will send approval letter informing him about the award.

**A) For Bidders Interested in Selected Items:**

Bidders interested in selected items are required to deposit 25% of the bid amount within 5 days. Of this, 10% will be retained as security (in addition to the EMD), and the bidder will be permitted to lift material equivalent to 15% of the bid value. The remaining balance can be paid in two installments & they will be allowed to lift material equivalent to installment amount. Both the EMD and the 10% security deposit (totaling 20%) will be adjusted against the final value of the last material lifted.

**B) For Bidders Interested in All Items:**

Bidders interested in the entire lot must deposit 20% of the bid amount within 5 days of the award. Out of this, 5% will be retained as security, and the bidder will be allowed to lift material equivalent to 15% of the bid value. The remaining balance can be paid in four installments & they will be allowed to lift material equivalent to installment amount. Both the EMD and the 5% security deposit (totaling 15%) will be adjusted against the final value of the last material lifted.

In the event of any breach of terms and conditions by the bidder—such as failure to make timely payments, refusal to lift the awarded material, misrepresentation, or any other non-compliance—the Earnest Money Deposit (EMD) and the Security Deposit will be forfeited.

**4) Lifting Terms.**

- 4.1)** All charges including cutting of salvage (if required) loading & lifting/ shifting of material from the place where it was lying at time of inspection will be borne by the purchaser.
- 4.2)** Lifting is to be made as per instruction of the seller, established principle being that more damaged material is to be lifted first unless otherwise agreed by Seller.
- 4.3)** The purchaser shall be required to lift the entire lot on clean sweep basis.
- 4.4)** The purchaser must lift entire material within 30 days after award positively. In case, due to any reason, the bidder fails to lift the material within 30 days, a grace period of 15 days will be allowed during which penalty of ₹1,000.00 per day will be paid by the bidder to the

Seller directly. No extension beyond this grace period will be entertained & would be treated as breach of award leading to forfeiture of EMD & security amount.

## **5) General Terms & Conditions**

**5.1)** Bidders are requested to read the Auction Document carefully and submit their offer as per terms and conditions given therein. Bidders who submit their offers shall be deemed to have read, understood and accepted the terms and conditions of the document.

### **5.2) Illegal Gratifications, Cartelling:**

If any bribe, commission, gift, or other form of advantage is offered, promised, or given—either directly or indirectly—by the Bidder, their partner, agent, servant, or any person acting on their behalf to any officer, employee, representative, or agent of the Company (or any person acting on behalf of the Company) in connection with the award or execution of this or any other contract with the Company, whether to secure favorable treatment or to influence a decision, the Company shall have the right to cancel the contract. In such a case, the Bidder shall be liable for any resulting loss or damage incurred due to such cancellation.
